Washington D.C. --- Fourth District Congressman Nick J. Rahall, (D-WV), announced today that the 4th District will receive, \$2,366,177 in Federal Revenue Sharing Funds for this quarter. The payments are made under the State and Local Government Fiscal Assistance Act of 1972. Rahall pointed out that the State of West Virginia will receive, \$16,864,733.
