WASHINGTON D.C. --- FOURTH DISTRICT CONGRESSMAN NICK J. RAHALL, (D-WV), HAS SPONSORED A RESOLUTION THAT URGES THE UNITED STATES HOUSE OF REPRESENTATIVES TO ASSERT ITS CONSTITUTIONAL ROLE WITH RESPECT TO THE DISPOSITION OF U.S. PROPERTY AND TERRITORY IN THE CANAL ZONE.

CONGRESSMAN

"I BELIEVE IT IS UNCONSTITUTIONAL AND INAPPROPRIATE FOR THE MULTI-BILLION DOLLAR INVESTMENT OF THE UNITED STATES IN THE CANAL ZONE, TO BE TRANSFERRED TO THE REPUBLIC OF PANAMA BY TREATY ALONE," RAHALL SAID.

CONGRESSMAN RAHALL POINTED OUT THAT, ARTICLE IV, SECTION 3, CLAUSE 2 OF THE CONSTITUTION GIVES TO CONGRESS THE EXCLUSIVE POWER TO DISPOSE OF U.S. PROPERTY AND TERRITORY. "FAILURE TO EXERCISE POWER IN THIS CRUCIAL QUESTION," RAHALL STATED, "WILL BE A BAD PRECEDENT FOR THE SEPARATION OF POWERS IN OUR GOVERNMENT."

H. CONCURRENT RESOLUTION 328, AT THE PRESENT TIME HAS 204 OTHER MEMBERS OF CONGRESS SUPPORTING IT. THE MEASURES CHIEF SPONSORS ARE REP. GEORGE HANSEN, (R-IDAHO), AND REP. JOHN M. MURPHY, (D-NY).

RAHALL OBSERVED THAT, "THIS IS A CONSTITUTIONAL ISSUE AND NOT ONE OF PARTISAN POLITICS. IT IS OUR DUTY AS ELECTED REPRESENTATIVES OF THE PEOPLE TO ASSURE THAT THEIR VOICE IS HEARD."

CONCURRENT RESOLUTION
