WASHINGTON D.C. --- WEST VIRGINIA FOURTH DISTRICT CONGRESSMAN NICK J. RAHALL, ANNOUNCED TODAY THAT THE 4TH DISTRICT WILL RECEIVE \$2,293,602 IN FEDERAL REVENUE SHARING FUNDS FOR THE FIRST QUARTER PERIOD, JANUARY 1980. THE ALLOTMENTS TO STATE AND LOCAL GOVERNMENTS ARE MADE BY THE OFFICE OF REVENUE SHARING IN ACCORDANCE WITH THE STATE AND LOCAL GOVERNMENT FISCAL ASSISTANCE ACT OF 1972.

RAHALL ALSO POINTED OUT, THAT THE STATE OF WEST VIRGINIA WILL RECEIVE A TOTAL OF \$15,486,522 IN THIS SAME PERIOD.
