## RAHALL TO HOST ADMINISTRATION OFFICIAL ON MINE TOUR

WASHINGTON D.C. --- WEST VIRGINIA'S 4TH DISTRICT CONGRESS-  
MAN NICK J. RAHALL, CHAIRMAN OF THE CONGRESSIONAL COAL GROUP,  
WILL HOST ASSISTANT SECRETARY OF COMMERCE WILLIAM MORRIS, ON A  
TOUR OF SOUTHERN WEST VIRGINIA DEEP MINES ON MONDAY, OCTOBER 19.

ASSISTANT SECRETARY MORRIS IS SCHEDULED TO ARRIVE AT RALEIGH  
COUNTY AIRPORT AT 9:30AM ON OCTOBER 19. THE EXACT DEEP MINE  
SITE HAS NOT BEEN ESTABLISHED, BUT FURTHER DETAILS WILL BE FORTH-  
COMING.

"I BELIEVE THIS WILL PROVIDE A UNIQUE OPPORTUNITY FOR MR.  
MORRIS," CONGRESSMAN RAHALL SAID, "BECAUSE AS CHAIRMAN OF THE  
REAGAN ADMINISTRATION'S COAL INTERAGENCY WORKING GROUP, HE WILL  
BE IN A POSITION TO BENEFIT COAL, AND IT IS IMPORTANT THAT HE  
HAVE AS MUCH INFORMATION AS POSSIBLE AVAILABLE."

WILL BE MADE OF SURFACE MINING SITES IN BARBOUR, TUCKER AND GRANT
