

Washington, D.C. -- U.S. Rep. Nick Rahall (D-WV) today announced a new film presentation dealing with federal tax laws affecting retired individuals. The new film, "A Less Taxing Retirement", produced by the Internal Revenue Service, is designed for retirement and community groups.

"A Less Taxing Retirement" portrays a tax lawyer who moves to a small community when he retires and finds that his tax expertise is in demand among its townspeople. Through his interaction with his new neighbors, the viewer learns about federal tax laws affecting pensions, I.R.A.'s, taxability of Social Security, and tax benefits for older Americans.
