RAHALL ANNOUNCES ADDITIONAL HOUSING VOUCHERS FOR HOUSING AUTHORITIES

WASHINGTON, DC - U.S. Rep. Nick Rahall (D-W.Va.) announced today that two Housing Authorities in Southern West Virginia have been allotted funds by the U.S. Department of Housing and Urban Development.

The Raleigh and Mingo County Housing Authorities have each been granted 100 additional vouchers under the Housing Voucher Program. That program allows persons unable to afford decent housing the opportunity to present vouchers in lieu of rental payments.

"This program allows for the use of already existing housing units to be utilized by those who cannot otherwise afford the high cost of housing," Rahall said. "The program is a major step in helping people receive housing without the costly construction of new low-rent housing units."

The new vouchers means an additional \$389,650 obliged to the Raleigh County Housing Authority bringing its total award to \$779,300. The Mingo County Authority was granted an additional \$407,925 bringing its total award to \$1,215,850.

The additional vouchers will be made available to the housing agencies on July 1.
