## RAHALL ANNOUNCES HUD FUNDS FOR AREA HOUSING AUTHORITIES

WASHINGTON, DC - U.S. Rep. Nick Rahall (D-W.Va.) announces that two Housing Authorities in Southern West Virginia have been allotted funds by the U.S. Department of Housing and Urban Development.

The voucher program allows those who are unable to afford decent housing the opportunity to present vouchers in lieu of rental payments.

"This program allows for the use of already existing housing units to be utilized by those who cannot otherwise afford the high cost of housing," Rahall said. "This program is a major step in helping these people while at the same time proving not as costly as constructing new low-rent housing units."
