HUNTINGTON HOUSING AUTHORITY SECURES FEDERAL DOLLARS

WASHINGTON, DC -- U.S. Rep. Nick Rahall (D-WV) announced today that the U.S. Department of Housing and Urban Development awarded \$589,603 to the Huntington Housing Authority (HHA).

This HOPE 3 Implementation Grant will be used to develop a single family homeownership program. HHA, in conjunction with the Coalition for the Homeless, will provide homeownership opportunities to twenty-five low-income, first-time homebuyers. Mortgage assistance will be provided by the West Virginia Housing Development Fund.

This program involves the acquisition and rehabilitation of properties in Cabell and Wayne Counties owned by HUD, the Veterans Administration, Resolution Trust Corporation, Farmers Home Administration, the State of West Virginia, and the City of Huntington. Additional funding from the Federal Home Loan Bank of Pittsburgh and the City of Huntington will bring the project total to \$2,125,172.

"This is a great program for Southern West Virginia", said Rahall. "It combines the government's resources to provide home ownership opportunities to low-income families."
