# \$40,000 TO AID CHILDREN OF DOMESTIC VIOLENCE VICTIMS

WASHINGTON, DC -- U.S. Rep. Nick Rahall (D-WV) announced today \$40,000 in federal support for a state-wide family crisis program.

Twenty members of Volunteers in Service to America (VISTA) will conduct summer programs for the children of domestic violence victims residing in shelters throughout West Virginia. The VISTA personnel will also work to raise the awareness of domestic violence and assist victims with court appearances.

"This is a great program," said Rahall. "These kids' families are torn apart, and they need all the support and assistance we can offer."

This summer, the Corporation for National and Community Service will focus its efforts on public safety by sponsoring a national Summer of Safety. The Summer of Safety is an eight to ten week service program that will utilize the energy and talent of over 6,000 Americans in direct, locally-based service to strengthen the ability of communities to respond to crime, violence and fear.

The Corporation for National Service administers the AmeriCorps program which includes AmeriCorps Grants, Volunteers in Service to America (VISTA), and the National Civilian Community Corps (NCCC). The National Senior Service Corps, which is also administered by the Corporation, includes the Retired and Senior Volunteer Program, Foster Grandparents, and Senior Companions.

The Corporation's programs are sponsoring Summer of Safety projects which will work on a range of public safety activities such as neighborhood crime watches, crime prevention education, community policing initiatives and victims assistance. The programs in your district include:
