RAHALL ANNOUNCES PRIMARY HEALTH CARE GRANTS

WASHINGTON, DC -- U.S. Rep. Nick Rahall (D-WV) announced today that the U.S. Department of Health and Human Services, Bureau of Primary Health Care awarded \$2.3 million worth of grants to three southern West Virginia health care providers.

Valley Health Systems of Huntington received \$1,958,231, Bluestone Health Association of Matoaka received \$213,230, and Northern Greenbrier Health Clinic of Williamsburg received \$171,932.

"This funding will improve access to health care and raise the quality of care for West Virginians served by these clinics," said Rahall.
