

\$200,000 FACILITATES MINGO COUNTY AIRPORT WATER EXTENSION

WASHINGTON, D.C. -- U.S. Rep. Nick Rahall (D-WV) announced today that the Appalachian Regional Commission has released \$200,000 in grant funds for the extension of a watermain and all necessary facilities from the City of Williamson to Mingo County Airport.

The water extension will serve the residents of Airport Hill, the ambulance service, the emergency service building, and the airport. The grant award will provide the following: one 5,000 gallon storage tank, eleven water meters, approximately 6,500 LF of water lines, a fifty gpm booster pump station, and other amenities which will modify the existing system.

"The modifications and additions to the existing water system in the City of Williamson will ensure the area's water supply," stated Rahall. "The funding will provide sufficient water quality and quantity for Mingo County Airport and the surrounding vicinity," Rahall continued. "The growth of this region's infrastructure will bring greater efficiency and economic security for both the airport and the residential community," Rahall concluded.

Washington, D. C. -- The Appalachian Regional Commission announced today approval of a \$200,000 grant for the extension of a watermain and all necessary appurtenances from the City of Williamson's existing lines to Airport Hill serving residents, the ambulance service, emergency service building and the airport.

The proposed project will include the following:

- (a) One (1) Storage Tank (5,000 gallon)
- (b) Eleven (11) water meters
- (c) Approximately 6,500 LF of water lines
- (d) 50 gpm booster pump station
- (d) Valves and miscellaneous modifications to the existing system

The proposed facilities will include a new distribution main, which ties to the existing City of Williamson water system at a location near the Valley View Sub Division. From this point, the new 6" and 4" main will parallel the road for a distance of approximately 6,500 feet. A new 5,000 gallon tank is proposed to be constructed on the hillside near the Appalachian Power Company Sub Station.

Alabama Georgia Kentucky Maryland Mississippi New York North Carolina Ohio Pennsylvania South Carolina Tennessee Virginia West Virginia Based on preliminary hydraulics, a 50 gpm booster pump station and 5,000 gallon tank will be required to supply water at acceptable domestic supply pressures.

In addition to the ARC funds, Mingo County Airport Authority is contributing \$30,000 and the Mingo County Commission is contributing \$20,000 for a total project cost of \$250,000.
