Nick Rahall (D-WV) today announced that the U.S. Postal Service has scheduled a town meeting for the residents of Monaville in Logan County, to discuss the future of the Monaville Post Office, which was closed early this year because of bat droppings in the ceiling area which were said to create a public health risk.

The meeting is scheduled for Thursday, July 28, 1994, from 5:30 to 6:30 p.m., at the Logan Post Office.

"I urge the residents of Monaville to attend this important meeting. The Postal Service will use a lack of citizens' participation in the meeting to support its effort to close Monaville. The meeting on the 28th is everyone's chance to be heard. If the residents of Monaville tell the Postal Service as a result of the Town Meeting that they are willing to use other services, such as the not-yet built Wilkinson Post Office, rather than to reopen Monaville, then I will abide by their decision," Rahall said.
