Greenbrier Airport Recieves Federal Funding

WASHINGTON, D.C. -- U. S. Rep. Nick Rahall (D-W.Va.) today announced the U.S. Department of Transportation has awarded the Greenbrier County Airport Authority a grant of \$265,485 to maintain the airport's taxiway and rehabilitate a portion of the terminal apron.

"This grant will allow Greenbrier's airport to extend the life of its taxiway and facilities. It is an effective and efficient method of maintaining our State's transportation infrastructure. I salute the Greenbrier Airport Authority for its vision in seeking these federal funds to provide for our aviation needs in the future.
