## WEST VIRGINIA WATER FUNDS PASS HOUSE

WASHINGTON, DC -- U.S. REP. NICK RAHALL TODAY JOINED A MAJORITY OF HIS HOUSE COLLEAGUES IN PASSING THE FY 1992 ENERGY AND WATER DEVELOPMENT APPROPRIATIONS BILL PROVIDING \$21.5 BILLION FOR THE ARMY CORPS OF ENGINEERS WATER PROJECTS, THE INTERIOR DEPARTMENT'S BUREAU OF RECLAMATION, AND AGENCIES SUCH AS THE APPALACHIAN REGIONAL COMMISSION (ARC).

Under the Bill, the ARC would be funded at \$170 million, \$70 Million more than proposed by the Administration. The appropriations also include funding for the Corps Section 14 program which will assist with the necessary funding for the work the Corps is performing in Kenova, W and is proposing for Barboursville, W in protecting its sewage lagoon which threatens the Town's wastewater treatment facility. Among other Corps projects in West Virginia to receive continued funding for next year are:
