RAHALL ANNOUNCES \$2,421 FOR VETERANS EDUCATION IN SOUTHERN WEST VIRGINIA

WASHINGTON DC - U.S. Rep. Nick J. Rahall (D-WV) announced today that Concord College of Athens, West Virginia and College of West Virginia in Beckley have been awarded \$1,285 and \$1,136, respectively, by the U.S. Department of Education. This money has been awarded under the Veterans Education Outreach Program.

Through Fiscal Year 1994, Concord College and College of West Virginia will use this funding to support their offices of veterans affairs which provide outreach and recruitment activities, counseling and tutorial services, and additional programs tailored to meet the educational needs of disabled and educationally disadvantaged veterans.

"Our veterans deserve an equal chance to participate in our higher education system," stated Rahall. "This grant will help them overcome some of the additional challenges they face as veterans."
