ATHENS STUDENT BECOMES KERR SCHOLAR

WASHINGTON, D.C. -- Bryan Manzo, a student at Athens High School in Athens, West Virginia, has been chosen as a 1992 Malcolm H. Kerr Scholar in Arab and Islamic studies, according to U.S. Rep. Nick Rahall (D-WV).

Bryan will be travelling to Kuwait in late June and will stay for approximately three weeks. During his stay, he will study Arab culture and affairs, meet with specialists in different fields important to Kuwaiti industry, and visit important cultural and governmental institutions throughout the country.

Since 1986, 218 Kerr Scholars have travelled throughout Egypt, Jordan, Syria and Kuwait logging 4,300 hours of community service along the way. The Kerr Scholars develop impressive insight into Arab affairs and use the experience to develop their communication skills.

Bryan is currently the vice-president of the student body at Athens High School. He is a member of the high school band and the football team, and has a strong interest in politics.

"Bryan is a fine young man who understands the ever-increasing need to understand the relationship the United States has with the Middle East. I am sure he will make the most of it," said Rahall.

I am pleased to inform you of your selection to participate in the 1992 Malcolm H. Kerr Scholars Program in Arab and Islamic Studies this Summer. You will join the delegation of Scholars traveling to Kuwait. We were most impressed by the high quality of the finalists.

Let me take a moment to inform you about some of the highlights of the program you'll experience this Summer. The Kerr Scholars Program is designed to afford young Americans the opportunity to project themselves academically, perceptually, and emotionally into the daily life of an Arab and Islamic society. About 40 percent of the Program's focus will be academic, including daily Arabic language instruction and lectures on historical and cultural topics. Another 30 percent will include meetings and briefings with specialists in different fields and visits to significant industrial, cultural, and governmental institutions. The remaining 30 percent can be used in a variety of ways, but most choose to engage in individual activities designed to foster acquaintances with host country nationals.

We realize that you and your parents, and perhaps some of your friends as well, might have concerns about U.S. citizens travelling in the Middle East. The National Council continues to monitor events closely in the region before and during the period of the Program. We have informed our embassies in Egypt, Jordan, Syria, and Kuwait about the programs and they are supportive, as are State Department officials.

As the Kerr Program brochure and each of the National Council's <u>Annual Reviews</u> have indicated, Presidents Reagan and Bush could hardly have provided a more upbeat endorsement of the Program since it began in 1984. The same can be said for the American Ambassadors and Embassy staff in the countries where the program is conducted. Please be assured that the National Council will err on the side of caution in matters relating to your safety. We would be most happy to discuss these matters with you and your parents at any time.

Your international flight will depart the afternoon of Friday, June 28 or Saturday, June 29, arriving the afternoon of the following day. You are scheduled to return on July 19 or July 20.

As indicated in the literature accompanying the application form, you are required to provide for your own round-trip air fare and ground transportation to Mount Vernon College, the site of the orientation program in Washington, D.C., and one meal a day during the in-country program. Your return flight should be booked from New York as international flights will return to JFK. Please do not make domestic flight plans until you have received your international itinerary.

Please indicate your acceptance or declination of the Scholar Award in writing to Ms. Alison Richards, Kerr Program Coordinator by April 3. If we have not heard from you by that time, we will award your place in the Program to one of the alternates. We also ask that you contact the chairperson of your Local Nominating Committee to offer your assistance in raising the required \$1250 from your community, eighty percent of which is due May 8, with the remainder required June 22.
