Dear Harley Staggers:

Thank you very much indeed for accepting my phone call from Hawaii last month.

We had an interesting and constructive convention and I am certain that our Washington office has acquainted you with the resolutions adopted at that convention urging all hotel and motel operators in our country and through them our guests to conserve energy in every possible way.

As the Congress considers and debates any general legislation controlling the distribution and sale of gasoline I hope that you will please keep in mind the more than 3,000 persons who are dependent on the success of The Greenbrier for their livelihood.

On an annual basis, 82% of our business is made up of those persons attending business conferences. Of these, 72 1/2% have, in the past, travelled by private automobile. Because of the usual convention scheduling in the early part of the week, or the end of the week, the principal days of arrival and departure at The Greenbrier are Sundays and Wednesdays. If there is legislation compelling gasoline stations to close on Sundays it will be utterly chaotic to attempt to reschedule meetings in order that people will not have to travel on Sunday.

Could there be some consideration given to having gasoline stations on the Interstate Highways open so that out-of-state registrants (which could be readily determined by car registration and driver's license) could secure the necessary fuel for vital business travel?



We have already suffered a few cancellations because of "the energy crisis" and we expect there will be more.

At best it will be a most difficult and frustrating year, but this of course we will handle to the best of our ability. It will be absolutely disastrous, however, if there is legislation requiring gasoline stations to remain closed over weekends and/or stringent rationing regulations.

I think it is safe to say that this same condition would prevail at most any remote resort and I hope that you and others in the House and the Senate will keep such serious things in mind as you prepare any regulations which may appear to be necessary during 1974.

You have our warmest best wishes for good health and happiness in the New Year.

Called from Hilo, Hawaii, and talked with HOS. He is there attending a national convention of the American Hotel Association.

Advised HOS that 82 per cent of the Greenbrier's business is from conventions and business meetings. Of that figure 75 per cent of the people arrive by car. The pattern has always been to arrive and depart on Wednesdays and Sundays. With no Sunday gasoline sales, this is, of course, going to hurt things.

Piedmont and American advise there will be no charter flights, as well as Southern Airways (no word yet from United). No special trains at any time will be run by Amtrak.

Requested HOS support of equal fuel allocation to all sectors of the economy in the Emergency Energy bill presently being considered by the Committee. (Goldwater-Rooney Amendment to H.R. 11450)
