Dear Mr. Staggers:

As the owner of a general aviation aircraft, I am seriously concerned about President Nixon's plans to cut our fuel by 40% to 50%. Obviously cuts are going to be necessary, and I would not object, providing other competing forms of commerce, transportation and personal use of fuels receive equal treatment.

I anticipate a 25% drop on the resale value of my aircraft. More importantly, I will be unable to maintain the level of competence in my profession which I am able to achieve through the mobility provided by my aircraft. I am able to attend seminars anywhere in the country with a minimum of time out of my office. If I were dependent on airline transportation out of Elkins I would lose a minimum of two additional days out of my office.

Please, Mr. Staggers, try to see that the fuel allotment is made on an equitable basis.
