Dear Chairman Staggers:

Two provisions in the conference report on the Energy Emergency Act are of urgent importance to the retailing industry.

The first would suspend parking surcharge provisions which have been promulgated by the Environmental Protection Agency, and would require EPA to conduct a study of the economic consequences of these surcharges. Further, the Act would postpone until 1975 various parking management provisions which EPA has promulgated. Both these suspensions offer protection from the possibly catastrophic consequences of ill-considered EPA action.

The second would provide a measure of administrative due process for those affected by programs instituted under the Act, providing opportunities for comment on those programs prior to their implementation.

Montgomery Ward strongly urges that nothing be done by the House which would jeopardize the adoption of these provisions. While we take no position on the merits of other provisions of the bill, we would hope that the House would support its Interstate and Foreign Commerce committee, so that the parking surcharge and administrative due process provisions may be securely written into law.
