Dear Sir:

I'm writing concerning the gas rationing plan which may go into effect on March 1, 1973. I drive 52.2 miles/day round trip to work - Martinsburg, W. Va. to Berkeley Springs, W. Va. I'm presently in a car pool with another individual; but, if the gas rationing pinch hits, he would probably move to Berkeley Springs. He lives in an apartment and has no children. I just graduated from college, am buying a house, and my wife is 4 months pregnant. Moving to Berkeley Springs would not be as easy for me even if I really wanted to move there.

I'll admit that I can probably make it to work and back on 70 gallons per month. However, I'm presently trying to pass the CPA exam; and although I have passed all but two parts, I feel that I will need professional assistance to finally get through. This would mean commuting to a CPA coaching school in Washington, D. C. I'll also need gasoline to commute to the nearest testing center. Under the present rationing system I can't be guaranteed gasoline for what I consider an important need. I may be able to buy extra coupons on the open market, but I'm not independently wealthy so I could only afford a modest price.

Please understand that my most important concern is getting enough gasoline so that I can get to and from work. However, I would like to be advised concerning future steps that might be taken to get extra gas to attend school. I need this information so that I can make arrangements for registration, etc.
