COMMITTEE FROM EACH HOUSE TO BE SELECTED BY CONGRESSIONAL  
LEADERSHIP VISIT ACTIVE THEATERS OF WAR COMMITTEES PRESENT  
ITINERARY WAS BASED ON THREE SPECIFIC REQUESTS OF CHAIRMAN KILGORE  
AS FOLLOWS THAT FIRST THAT COMMITTEE BE AUTHORIZED TO GOT TO ANY
