SUBJECT: INSPECTION OF DEPOTS

THURSDAY, SEPTEMBER 14, 1944

Army plane to leave Washington after luncheon, flying to Columbus, Ohio (air distance approximately 329 miles), where the Army Service Forces Depot will be inspected. Reservations will be made at Deshler-Wallick Hotel, Columbus.

FRIDAY, SEPTEMBER 15, 1944

Hearing at the Army Service Forces Depot concerning the recent reorganization of stock control and inventory in the Engineers' Section of that depot, Columbus, Ohio. Late afternoon depart for Memphis, Tennessee (air distance 513 miles). Reservations will be made at the Hotel Peabody.

SATURDAY, SEPTEMBER 16, 1944

MONDAY, SEPTEMBER 18, 1944

Depot, Montgomery, Alabama. Late afternoon depart for Atlanta, Georgia (air distance 149 miles). Reservations will be made at the Piedmont Hotel.
